A new value will be added to this list to allow customers to enter text that was previously input in the narrative field in the General Information Tab of the Corporate Action Pre Release instruction and to display its content in the Corporate Action Post Release instruction.
- The field Requested Tax Rate will be renamed Requested Withholding Tax Rate.

Reference Data - Place of Safekeeping Query

The Country Code will now display the country of the place of safekeeping of the financial instrument.

Corporate Action Respond Upload Template

Three fields will be removed. The Narrative Version field will be replaced by three new fields.

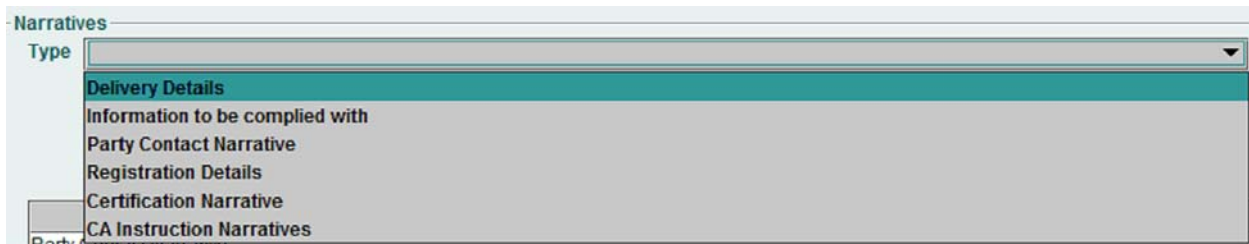

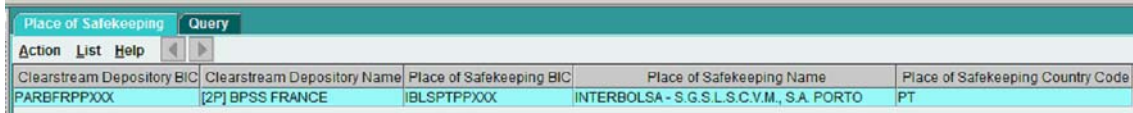

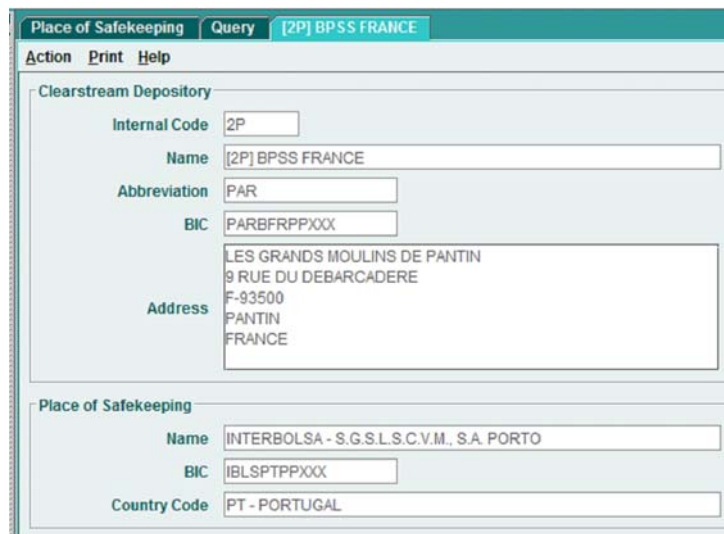
